WHEREAS, the undersigned has applied to the Building Official of the City of Northport for the issuance of a permit for moving of a house and/or building from, to or through the City of Northport and its Police Jurisdiction.

WHEREAS, Section 22-32-(14) of the Code of Northport, Alabama requires the execution of this Indemnity Agreement among certain other requirements before such a permit may be issued, and,

THEREFORE, in consideration of the issuance of said moving permit, it is agreed as follows:

(1) The undersigned does hereby agree to indemnify, define and hold harmless the City of Northport, its elected officials, employees and agents from any and all claims, suits or demands for damage to property, injury or death to person which arise from or relate to any activities undertaken by the undersigned, the undersigned’s agents, servants, employees or independent contractors related to the moving of any house or building or any part thereof upon, across or through the corporate limits or police jurisdiction of the City of Northport.

(2) This agreement shall continue in full force and effect indefinitely.

(3) This agreement shall be binding upon the executors, administrators, heirs, successors and assigns of the undersigned.

(4) The undersigned further agrees to pay all costs expenses and attorney fee incurred by the City of Northport for the enforcement of this agreement whether suit or otherwise.

## CITY OF NORTHPORT

### REQUIREMENTS FOR MOVING A STRUCTURE

Any person desiring to move a building shall first file a written application with the Building Official setting forth the following information:

1. The extreme dimension and the length, height and width of the building.
2. Its present location and proposed new location by lot, block, subdivision and street number.
3. Date and time of moving.
4. The contemplated route that will be taken from the present to the new location. Route must be approved by Police Chief.
5. If structure is moved within the City Limits:
  - a. A sight plan will be required and approved by the Planning and Engineering Departments.
  - b. A building permit will be required with Architect/Engineer certification of structural designs, footings, repairs, etc.

**\*If structure is to be for commercial use, it will need to meet the Design Review Ordinance requirements.**

6. Sign "Hold Harmless Agreement".
7. If structure is moved within the Police Jurisdiction:
  - a. A building permit will be required with Architect/Engineer certification of structural designs, footings, repairs, etc.
